What is different about New Age Litigation is first, the size and complexity of litigation, and second, the genuine and very real tension between the needs for efficiency and due process.





## FINANCIAL OVERVIEW

In 2008, the NFJE raised over \$283,000 with the generous support of individual attorneys, law firms, corporations, State and Local Defense Organizations, professional organizations, DRI dues renewal checkoff and foundations. The John R. Kouris Endowment Fund was created in the spring of 2008 in honor of Mr. Kouris' 10 years of service to DRI. This fund directly supports keynote speaker honorarium for each annual symposium.

Expenses for 2008 accurately reflect the NFJE mission – education of the judiciary. The annual symposium remains the largest expense for the NFJE at fifty-eight (58%) percent. Management and General expenses reflect the operating costs. Fundraising expenses reflect the printing of materials and travel costs related to fundraising.
