We live in extraordinary times during which our institutions face unprecedented pressures amid a climate of fading trust. The judiciary is no exception. Threats and inappropriate communications to federal and state courts and judges have increased significantly in the past decade. Meanwhile, public confidence in the judicial branch continues to decline and Americans are losing faith in the courts' ability to deliver on the key promise of justice for all.

A well-educated, independent judiciary is the best antidote to these pressures of the times. Our 19th Annual Judicial Symposium seeks to provide state court appellate judges with valuable insight on these and other important and timely issues. As our keynote address, the Honorable Goodwin H. Liu of the Supreme Court of California—a leading scholar on state constitutional law—will share insights about the importance in interpreting state constitutional provisions. An esteemed panel of experts will discuss measures to improve judicial security and courthouse safety. Back by popular demand, the Honorable Robert E. Bacharach of the U.S. Court of Appeals for the Tenth Circuit will share strategies for effective opinion writing. Improving security for judges and ensuring safety in courthouses is an increasing concern for courts around the United States. In December 2022, Congress passed the *Daniel Anderl Judicial Security and Privacy Act*—named after U.S. District Court Judge Esther Salas's son, who was killed in an assassination attempt on her—to protect personal information and increase protection for federal judges and their families. Different state courts also have been evaluating ways to improve judicial security and courthouse safety, including review of facility safety standards, protection of personal information, responding to threats, and other measures. This panel will discuss what measures state courts should consider to improve judicial safety and security.

Improving Rule 702

In 2022, the Committee on Rules of Practice and Procedure voted unanimously to approve an amendment to Federal Rule of Evidence 702. Aimed at clarifying the standards for admission of expert testimony, the amendment is expected to take effect December 1, 2023, with changes likely to follow in state analogs. Duty, Causation, and the Restatement (Third) of Torts

The panel will examine longstanding concepts of duty and causation and their role in litigation in light of changes in the Restatement (Third) of Torts. Duty and causation both have traditionally included a focus on foreseeability as a limit to liability and on whether a defendant's conduct was a substantial factor in causing the complained-of injury. These debates go back to the dispute between the majority and dissenting opinions of Judge Cardozo and Judge Andrews in *Palsgraf v. Long Island R.R.*, 248 N.Y. 339, 362 N.W. 99 (1928). And they arise over and over again in modern times. The discussion will shed light on the perennial question about the proper role of the judge and the jury.

The Honorable Robert E. Bacharach sits on the United States Court of Appeals for the Tenth Circuit, with his chambers in Oklahoma City, Oklahoma. Judge Bacharach graduated from Washington University School of Law in 1985, where he was named to the Order of the Coif. He served for two years as a clerk for Judge William J. Holloway, Jr. on the Tenth Circuit, and then worked for 12 years as a commercial litigator for the Oklahoma firm of Crowe & Dunlevy. In 1999, Judge Bacharach became a magistrate judge for the Western District of Oklahoma, where he presided over thousands of civil and criminal cases. He was appointed to the Tenth Circuit in 2013. Judge Bacharach recently published a new book on legal writing called *Legal Writing: A Judge's Perspective on the Science and Rhetoric of the Written Word*.



Tillman Breckenridge is a partner at the firm of Stris & Maher LLP in Washington, D.C. Mr. Breckenridge is an experienced appellate lawyer whose practice includes a diverse array of appellate litigation matters at all levels. He has represented companies, organizations, individuals, and foreign, state, and local governments before the United States Supreme Court, every federal court of appeals, and different state courts. Mr. Breckenridge also has been an adjunct professor of law at William and Mary Law School, where he founded the Appellate & Supreme Court Clinic. He has been named to Savoy Magazine's Most Influential Black Lawyers in America, an honorary member of the Order of the Barristers, a Washington, D.C. SuperLawyer, and a member of Virginia's Legal Elite. He also became the youngest fellow ever—and first under 40—in the American Academy of Appellate Lawyers. In addition to his appellate practice, Mr. Breckenridge speaks on appellate and related topics to various audiences.



The Honorable Mathias W. Delort sits on the Illinois Appellate Court, with his chambers in Chicago, Illinois. Justice Delort earned his B.S. in mathematics *cum laude* from DePaul University and his J.D. from the University of Illinois Chicago Law School (formerly The John Marshall Law School), where he was awarded the Dean's academic scholarship. He also holds a master's degree in public administration (M.P.A.) from the University of Illinois. Justice Delort was appointed as an Associate Judge of the Circuit Court of Cook County in 2007 and served almost exclusively in the Chancery Division of that court. Elevated to the appellate court in 2012, Justice Delort has served both as presiding justice of several divisions of that court and as chair of the court's Mediation Committee. Before becoming a judge, he was a partner and head of the Local Government Practice Group of Robbins, Schwartz, Nicholas, Lifton & Taylor, Ltd. (now known as Robbins Schwartz), specializing in local government and election law.



Thomas H. Dupree Jr. is Co-Partner-in-Charge of the Washington, DC office of Gibson, Dunn & Crutcher and co-chair of the firm's nationwide Appellate and Constitutional Law practice group. Mr. Dupree has argued more than 100 appeals in the federal courts, including in all thirteen circuits as well as the United States Supreme Court. Chambers and Partners has named Mr. Dupree one of the leading appellate lawyers in the United States every year from 2012 through 2023.

Mr. Dupree previously served in the United States Department of Justice as the Principal Deputy Assistant Attorney General. In that capacity, he served as the division's second-in-command, overseeing more than 900 lawyers and managing many of the government's most significant cases involving regulatory, commercial, constitutional and national security matters on behalf of virtually all of the federal agencies, the White House, and senior federal officials.

Legal Times has called Mr. Dupree "no stranger to high-profile work." Among other things, he played a substantial role in the successful representation of George W. Bush before the United States Supreme Court in Bush v. Gore, and represented New England Patriots quarterback Tom Brady in challenging his "Deflategate" suspension. He also argued and won, by a unanimous 9-0 vote, a landmark personal jurisdiction case in the United States Supreme Court, Daimler AG v. Bauman.

Mr. Dupree appears frequently on national television as a legal analyst. He is a regular guest on Fox News Channel and CNN, and has testified before Congress on constitutional and separation-of-powers issues, including the President's authority to act through executive order.



Mark Fahleson is a partner with the firm Rembolt Ludtke in Lincoln, Nebraska. Mr. Fahleson serves as an attorney and advisor to businesses, organizations, insurers, governmental bodies, officials, and individuals. Nathan Hall is a registered Architect and Principal Consultant for the National Center for State Courts. Since joining the National Center in 2008, he has been involved in over 150 court security assessment and facility planning projects for state and local courts across the nation and internationally. Mr. Hall also provides training nationally to professionals in the areas of court security & emergency planning as well as courthouse planning & design.



Bruce Jackson is an associate general counsel at Microsoft and managing director for strategic partnerships out of the office of the president at Microsoft. The Honorable Goodwin H. Liu is an Associate Justice of the California Supreme Court. Nominated by Governor Jerry Brown, Justice Liu was sworn into office in 2011 and retained by the electorate in 2014 and 2022. Before joining the state's highest court, Justice Liu was Professor of Law and Associate Dean at the UC Berkeley School of Law. His primary areas of expertise are constitutional law, education law and policy, and diversity in the legal profession. Justice Liu continues to teach constitutional law as a visiting professor at Harvard Law School, Columbia Law School, and Stanford Law School. He is an elected member of the American Academy of Arts & Sciences, the American Law Institute, and the American Philosophical Society. In 2023, he was elected Chair of the Board of Directors of the American Academy of Arts & Sciences. He also serves on the Council of the American Law Institute, on the Board of Directors of the James Irvine Foundation, and as President of the Yale University Council. He has previously served on the Board of Trustees of Stanford University, the National Academy of Sciences Committee on Science, Technology, and Law, the Board of Directors of the National Women's Law Center, and the California Commission on Access to Justice.

The son of Taiwanese immigrants, Justice Liu grew up in Sacramento and attended public schools. He earned a bachelor's degree in biology from Stanford, a masters degree in philosophy and physiology from Oxford University on a Rhodes Scholarship, and a law degree from Yale. He clerked for Judge David Tatel on the U.S. Court of Appeals for the D.C. Circuit and for Justice Ruth Bader Ginsburg on the U.S. Supreme Court. He has also worked in the litigation practice of O'Melveny & Myers, served as Special Assistant to the Deputy Secretary of the U.S. Department of Education, and helped launch the AmeriCorps national service program as Senior Program Officer for Higher Education at the Corporation for National Service.



The Honorable Stephen Markman served as Justice of the Michigan Supreme for 21 years and as its Chief Justice. He earlier served as the U.S. Attorney in Michigan and as Assistant Attorney General for Legal Policy, where he coordinated policy development and federal judicial selection under President Reagan. Previously, he served for seven years as Chief Counsel of the U.S. Senate Subcommittee on the Constitution. He has taught constitutional law at Hillsdale College in Michigan for nearly 30 years.



Mary Massaron has been an appellate lawyer with Plunkett Cooney, practicing in state and federal courts throughout the country for thirty years. Ms. Massaron served as only the second female president of DRI, and the first woman president of Lawyers for Civil Justice (LCJ). In recognition of her professional accomplishments, Ms. Massaron was inducted into the American Academy of Appellate Lawyers, one of only a handful of Michigan lawyers to be invited to join. She also is a member of the American Law Institute and a past chair of the ABA Council of Appellate Lawyers, a division of the Appellate Judges Conference. A regular before the Michigan Supreme Court where she clerked for Justice Patricia J. Boyle, she currently chairs its Advocates Guild. She has twice received WMU Cooley Law School's distinguished brief award.
